### **Biographies**

## **Professor Mary Donnelly**



Professor Mary Donnelly is a Professor and Vice Dean of the School of Law at University College Cork. She researches in the fields of mental capacity/mental health/health law. Her books include Healthcare Decision-Making and the Law: Autonomy, Capacity and the Limits of Liberalism (Cambridge: Cambridge University Press, 2010) and she is co-author of End-of-Life Care: Ethics and Law (Cork University Press, 2011) and co-editor of Ethical and Legal Debates in Irish Healthcare: Confronting Complexities (Manchester University Press, 2016). She was a member of the Expert Group to review the Mental Health Act 2001 (2013-2015) and is a member of the Mental Health Commission Legislation Committee. She was Chair of the Technical Expert Group to develop Codes of Practice under the Assisted Decision-Making (Capacity) Act 2015. She is the joint chair of the HSE National Consent Advisory Group. She is Chair of the HSE Assisted Decision Making Steering Group and Chair of the Advance Healthcare Directives Multidisciplinary Working Group.

Ms. Áine Flynn



Ms. Áine Flynn graduated from Trinity College Dublin with a law degree and M.Litt. by research. She was admitted as a solicitor in 1999 and from 2012-2017 was a senior partner in KOD Lyons, a firm specialising in public interest law, including disability and equality law. She was on the panel of legal representatives of the Mental Health Commission and the Mental Health (Criminal Law) Review Board from their inception in 2006 and also represented Wards of Court instructed by the General Solicitor. She has written and lectured on Human Rights and has been a member of the Human Rights Committee of the Law Society since 2012. Prior to her present appointment, she was a member of the Law Society's Mental Health and Decision-Making Capacity Task Force. In October 2017, Áine commenced in post as inaugural Director of the Decision Support Service within the Mental Health Commission.

**Dr. Joan McCarthy** is a Senior Lecturer in Healthcare Ethics in the School of Nursing and Midwifery, University College Cork, and a Visiting Professor in the Faculty of Health and Medical Sciences, University of Surrey, UK. Her research interests include: ethics at the beginning and end of life; nursing and midwifery ethics, and; feminist perspectives on bioethics. She has led, and collaborated on, a number of national and international research projects funded by, e.g., the Irish Hospice Foundation, Wellcome Trust, and the Irish Research Council. Her publications include: *End-of-Life Care: Ethics and Law*, 2011, Cork: Cork University Press (with M. Donnelly, D. Dooley, L. Campbell and D. Smith) and *Nursing Ethics, Irish Cases and Concerns*, 2012, Dublin: Gill and MacMillan (with D. Dooley). Mr. Alex Ruck Keene is an experienced English barrister, writer and educator. His practice (at 39 Essex Chambers in London) is focused on mental capacity law (broadly defined). He has appeared in cases involving the Mental Capacity Act 2005 at all levels up to and including the United Kingdom Supreme Court and the European Court of Human Rights. He also writes extensively in the field, editing and contributing to leading textbooks and (amongst many other publications) the 39 Essex Chambers Mental Capacity Law Report, the 'bible' for solicitors (and others) working in the area.

Alex is the creator of the website <a href="www.mentalcapacitylawandpolicy.org.uk">www.mentalcapacitylawandpolicy.org.uk</a>, providing resources and expert commentary on some of the most difficult mental capacity issues. Alex is a Visiting Senior Lecturer at the Institute of Psychiatry, Psychology and Neuroscience at King's College London, a Visiting Lecturer at the College's Dickson Poon School of Law, and a Wellcome Trust Research Fellow there, working on the collaborative Mental Health and Justice project for the period 2017-2022. He spent from November 2016 to March 2017 on secondment to the Law Commission of England & Wales as a consultant to their Mental Capacity and Deprivation of Liberty Project, and 2018 as legal adviser to the Independent Review of the Mental Health Act 1983 in England & Wales. Alex has a particular interest in comparative mental capacity law, co-editing *The International Protection of Adults* (OUP, 2015), contributing to a forthcoming textbook on assessment of mental capacity in New Zealand, and – closer to home – providing input into law reform processes in the Republic of Ireland, Northern Ireland and Scotland.

**Dr. Fiona Morrissey** 



Dr. Fiona Morrissey completed a PhD in disability law at the Centre for Disability Law and Policy at NUI, Galway in 2014, which focused on the implementation of a legal framework for advance healthcare directives in Ireland. She is particularly interested in affecting cultural change towards human rights-based approaches which focus on the 'voice' of the person in healthcare and related services. Her research has been published in international journals and books including the European Journal of Health Law and the Journal of Ethics, Medicine and Public Health. As part of her research, Fiona spent a period in the State of Virginia in the United States examining the effective implementation of advance healthcare directives in the healthcare system. Fiona has been actively involved in capacity law reform in Ireland and internationally since 2009. She was involved in the campaign leading to the enactment of the Assisted Decision-Making (Capacity) Act 2015 (ADMA), and prepared legislative submissions to the Department of Health on behalf of the Irish Mental Health Commission and other bodies. Fiona is a member of the national working group, which was established to develop Codes of Practice for advance healthcare directives under the Assisted Decision-Making (Capacity) Act 2015. She is currently involved in delivering a new WHO based training programme for health professionals, which promotes human rights standards in healthcare and disability related services internationally.

Dr. Brendan O'Shea



**Dr Brendan O' Shea, MD FRCGP MICGP** is a GP & Principal in Practice in Co Kildare, on Council at The Irish College of General Practitioners, and Assistant Adjuvant Professor at Trinity College Dublin. Professional interests include improving care for people with multimorbidities, end of life planning and overweight. He presently chairs The Clinical Advisory Group at the RCPI on Obesity, and is on Board of Directors at The Irish Hospice Foundation. He has previously acted as Irish Representative on Council at EURACT, and also as Director PRC at the ICGP. Non withstanding somewhat intractable difficulties within the Irish Health System, he practices being a committed rational optimist, and frequently and casually but systematically avails of inspiration and energy from people attending for care, and from students.

Dr. Helen Rochford Brennan



**Dr. Helen Rochford-Brennan** is the current Chairperson of the European Working Group of People with Dementia and is the group's nominee to the Board of Alzheimer Europe; she is former Chair of the Irish Dementia Working Group. Helen is on the Monitoring Committee of Ireland's first National Dementia Strategy and a Global Dementia Ambassador. Throughout her time with these organisations she has campaigned to raise awareness of dementia through a Rights based approach, to the media, speaking at international conference's, engaging with pharma, scientists, clinicians, educators, students and many research projects from developing evidence —based diagnosis to palliative care. Helen was diagnosed after a five year struggle with Early Onset Alzheimer's at the age of 62 and has since written very personally about living with Alzheimer type of dementia. She hopes her participation in research will one day help find a cure. Despite her pain of coping with short term memory on a daily basis she continues to volunteer with support trying to make the







change she wants to see in the world. Throughout Helen's life she has been a Rights and Social Justice Campaigner and today advocates for the Rights of People with Dementia in particular Alzheimer's disease. Helen has received awards for her advocacy work and last year was awarded an Honorary Doctor of Laws degree from the National University of Ireland Galway.

She has contributed to books:

Helen is currently collaborating on books with Salford and Hull Universities and a documentary film for GBHI on life with Dementia. Creating awareness of Dementia in her community and throughout Ireland plus enjoyment with her family and friends is her greatest joy.

#### **Professor Brendan Kelly**



Professor Brendan Kelly is Professor of Psychiatry at Trinity College Dublin, Consultant Psychiatrist at Tallaght University Hospital, Dublin, and UCD Visiting Full Clinical Professor at University College Dublin School of Medicine and Medical Sciences. In addition to his medical degree (MB BCh BAO), he holds masters degrees in epidemiology (MSc), healthcare management (MA) and Buddhist studies (MA); and doctorates in medicine (MD), history (PhD), governance (DGov) and law (PhD). He has authored and co-authored over 250 publications in peer-reviewed journals, over 500 non-peer-reviewed publications, 13 book chapters and contributions, and 11 books (eight as sole author). His recent books include 'Hearing Voices: The History of Psychiatry in Ireland' (2016), 'Mental Illness, Human Rights and the Law' (2016) and 'The Doctor Who Sat For A Year' (2019). He is a Fellow of the Royal College of Psychiatrists, the Royal College of Physicians of Ireland, and Trinity College Dublin. In 2017, he became Editor-in-Chief of the *International Journal of Law and Psychiatry*.

#### Dr. Patricia Rickard Clarke



**Dr. Patricia Rickard-Clarke** is a solicitor and former Commissioner of the Law Reform Commission. She is the Independent Chair of the Safeguarding Ireland, Chair of SAGE Advocacy clg, a Board Member of Third Age Foundation clg. She is a member of the HSE's National Assisted Decision-Making (Capacity) Act Steering Group preparing for the implementation of the *Assisted Decision-Making (Capacity) Act 2015*, a member of the Multi-Disciplinary Group appointed by the Minister for Health to draft a code of practice for Advance Healthcare Directives and was a member of the National Disability Authority's Expert Group that developed the non-health care codes of practice for the 2015 Act. She has contributed to a number of publication including the Irish section of the publication on the *International Protection of Adults* published by Oxford University Press.

## Ms. Caoimhe Gleeson



Ms. Caoimhe Gleeson is the National Programme Lead for Assisted Decision Making in the HSE and has overseen the drafting of the Healthcare Codes of Practice on the Assisted Decision Making (Capacity) Act 2015 on behalf of the Decision Support Service and the Minister for Health. She is a member of the National Disability Authority Technical Group who drafted the non-healthcare Codes of Practice on the 2015 Act on behalf of the Department of Justice.
